



## MINISTERIAL DIRECTIVE

### ***Responsibility for Health and Social Services Facilities***

**MD 2025-04**

---

#### **1. Directive**

This Ministerial Directive is issued under s.5(3) and s.10(3) of the *Hospital Insurance and Health and Social Services Act* (HIHSSA) to specify facilities for which each Health and Social Services Authority (HSSA) is responsible for the provision of health and social services, as outlined in Appendix A.

#### **2. Background**

HIHSSA establishes the hospital insurance plan and sets out the authority for the administration and control of the health and social services system through Boards of Management.

Schedule A of the *Hospital Insurance Regulations* lists the approved facilities in the Northwest Territories (NWT) for the purpose of the hospital insurance plan. This directive specifies which HSSA is responsible for each facility listed in Schedule A.

Under HIHSSA the Minister has the power to:

- by order or directive, specify one or more facilities, health services or social services for which the Territorial authority is responsible (s.5(3)).
- by order or directive, specify one or more facilities, health services or social services for which a Board of Management is responsible (s.10(3)).

#### **Purpose**

This Ministerial Directive requires each of the HSSAs be responsible for the provision of health and social services in facilities approved under Schedule A of the *Hospital Insurance Regulations* as outlined in Appendix A, pursuant to s.5(3) and s.10(3) of HIHSSA.



### 3. Definitions

“Facility” means premises in or from which health services or social services are provided, and equipment in or associated with the premises, or associated with the provision of health services or social services from the premises.

“Health services” include:

- (a) services for the protection, promotion and maintenance of physical and mental health,
- (b) services for the prevention, diagnosis and treatment of illness, disease and injury,
- (c) palliative services,
- (d) rehabilitative care services,
- (e) insured services,
- (f) services in respect of public health surveillance, and
- (g) health programs and services approved by the Minister as health services.

“Health & Social Services Authorities” means the Territorial Health and Social Services Authority established under section 5(1) of HIHSSA, a Board of Management established under section 10(1) or referred to in subsection 10.2 or 10.3 of HIHSSA, or an organization, agency or firm contracted by the Minister pursuant to section 17 of HIHSSA.

“Hospital” means a facility approved by the Minister offering in-patient or out-patient services, or both, operated for the care of the diseased, injured or sick and includes

- (a) a detoxification centre, and
- (b) a facility providing long-term care and related services,

but does not include

- (c) a tuberculosis hospital or sanatorium,
- (d) a hospital or institution for the mentally ill,
- (e) a home for the aged, or
- (f) an infirmary or other institution providing custodial care;

“Social services” include:



- (a) services for the protection of children,
- (b) services in respect of adoption,
- (c) services in respect of the guardianship of adults, and
- (d) social programs and services approved by the Minister as social services.

**4. Exceptions**

None.

**5. Amendment**

The Minister may amend this Directive from time to time.

**6. Effective Date**

This Directive comes into effect on date of signing.

**7. Expiry**

This Directive is in effect, as amended from time to time, until it is repealed by the Minister.
