### Title: Immunization Protocol Following Hematopoietic Stem Cell Transplant

#### Statement of approved Clinical Practice:

On the recommendation of the NWT Advisory Committee for Immunization, the Chief Public Health Officer (CPHO) has reviewed Federal, Provincial and Territorial practice information guiding immunization following Hematopoietic stem cell transplant.

As a result, the CPHO has directed that the Alberta Health Services "Immunization Recommendations for Transplant Recipients" (linked below) shall be the standard of practice for immunizers in the NWT.
