CONTINUING COMPETENCY PROGRAM FOR NWT SOCIAL WORKERS

The Continuing Competency Program helps ensure that social workers maintain a standard level of competence. Upon renewal of registration, applicants must sign a statutory declaration stating that they have completed the Continuing Competency requirements. If, at the time of license renewal, a registrant has not been on the register for a full year, the Registrar will have discretion to waive the requirements.

Registrants will be required to complete 40 hours of formal or informal activities or a combination of the two. Registrants will be required to keep a log book noting their completion of continuing competency requirements. Every 3 years, the Registrar will request that all registrants sign a statutory declaration declaring that they have completed the requirements. Registrants may be asked to submit their log sheets from time to time.

A maximum of 80 excess hours may be carried over the next two years.
