## Vital Statistics Act; Change of Name Act

## APPLICATION TO WAIVE FEES FOR A NAME CHANGE AND RELATED CERTIFICATES

This form can be used by the following individuals:

- Residential School Survivors who reside in the NWT and their family members who want to reclaim a name;
- Indigenous NWT residents who want to change their name to a single name;
- Indigenous NWT residents and their family members who want to change their name because of an historical error made on their NWT birth registration form; or
- Indigenous Persons and their family members who were born in the NWT but who have changed their name in the province/territory where they now live\*\* to reclaim a name or to correct an historical error made on their NWT birth registration form.

## Notes:

- NWT in this document means Northwest Territories.
- An "Indigenous NWT resident" is a First Nations, Inuit or Métis resident of the NWT.
- \*\*Change of Name applications must be filed in the province/territory where you live. If you live outside of the NWT, the change of name fee cannot be waived by using this form.

## IMPORTANT INFORMATION:

Submit this application with your NWT Change of Name Application (Adult and/or Child) to apply to waive the change of name fee. You can also use this form to apply to waive the fee for birth/marriage certificates issued under the *Vital Statistics Act* if the event occurred in the NWT. Fees will only be waived once.
